SUBMISSION GUIDELINES

- 1. Article must be in English (Standard British) prepared on a standard A4 size paper setting. It must be prepared in 12-point Times New Roman.
- 2. Each Article requires an abstract with a length of 10-15 lines (maximum 200 words) in 12 point font Times New Roman and Italic, followed by 4-5 keywords.
- 3. Type-written Articles in MS Word (.doc) format should be submitted by E-mail to uulawjournal@gmail.com
- 4. Articles will be published in the Journal after peer-review process. The article must be original piece of work. The author should declare that the article has not been sent/published anywhere earlier and is not in consideration for publication anywhere else.
- 5. Leave 1 inch margin for each top, bottom, left and right.

- 6. Foot notes & Bibliography must be presented. Authors are instructed to use Chicago Style in Footnotes and Bibliography based on *The Chicago Manual of Style*, 16th ed. (2010). (See enclosed)
- 7. Papers without references will not be reviewed.
- 8. Section headers will be bold faced sentence case whereas sub-section header will be in normal style, both indented at 0.5 inch.
- 9. Once the paper is accepted, the authors will be required to send the signed copy of Copyright Form by E-mail to uulawjournal@gmail.com
- 10. It is mandatory for all the authors to sign the Copyright Transfer Form.
- 11. The decision of Reviewers will be final and canvassing in any form will be disqualification of authors in future issues.

REVIEW PROCESS

- 1. Each manuscript will be primarily examined by the editor, and then forwarded to a referee for blind review. The research paper shall be published subject to recommendation of referee. The review process may take up to 4 to 8 weeks.
- 2. The authors will be informed about the selection/rejection of the article by e-mail only. However, the journal shall publish the article of the authors completing the formalities in due time mentioned in the selection letter. The rejected papers shall not be returned.
- 3. In case of acceptance of the article and completion of publication formalities by the author, journal reserves the right of making amendments in the final draft of the research paper to suit the journal's requirement.
